1. all about dance® will provide private use of the facility for 2 hours and will provide entertainment which may include dance related routines and performances.
2. all about dance® will provide make-up, water bottles (with aad stickers and bracelet) if birthday party is held at AAD, tables and chairs to accommodate food, gifts, and guests.
3. Birthday hosts will be responsible for food, beverages, and paper products. All Parties supplies can be dropped off prior to the party.
4. Parents are invited to attend the final 15 minutes of the party for their children's performance of the routine they will learn.
5. As a friendly reminder, we recommend that parents socialize in the lobby during the dancing portion of the party as it is a distraction to some kids to allow all the parents in the dance room. Birthday parents are to stay in the studio during the entire party. We will again invite parents in the final 15 minutes of the party to see all the cool moves they learned throughout the party!

Terms of the Contract:

all about dance® requires a 50% deposit at the time of booking to insure reservation of the date. The remaining 50% will be due in full the day of the party. Payments can be made by cash, check, Visa or MasterCard.

Prices:

For a one-hour party off site:

\$275 + \$5 per water bottle

For a two-hour party on site:

\$625 (only \$575 for all about dance® students!)

Late Policy:

Please take into consideration that when you book a party, you are bound to your time slot. If you arrive late, we cannot extend the end time of your party.

Cancellation Policy:

In the event that you choose to cancel your party, you must call two weeks prior to the date in order to receive a refund of your 50% deposit. If you cancel any later than that, we will not be able to refund your deposit. If you cancel any later than 48 hours prior to the time of your party, you will be charged the full amount.

Hosts are responsible for their guests per the terms of the attached release of liability. Hosts are also responsible to remain with the children until they are picked up by their parents or appropriate guardians.
